

UNIVERSITY RULES GOVERNING FUNDING OF STUDY AND TRAINEESHIP TRAVEL UNDER THE ERASMUS+ PROGRAMME IN THE ACADEMIC YEAR 2020/2021

1. Each student qualified for the travel, and in the case of traineeship, also a graduate, will receive an individual grant from the University to cover costs related to travel and stay for the period declared in the agreement concluded between the student (graduate) and the University, represented by the Rector of Adam Mickiewicz University, at the following monthly rates:

- 2. The mobility participant will receive funding for the duration of the stay abroad even if the study/traineeship will only be provided remotely/virtually/on-line;
- 3. The final amount for the period of funded mobility will be determined by multiplying the number of study/traineeship months by the monthly rate applicable for the country (see the table above). In the case of an incomplete month, the amount of funding will be calculated by multiplying the number of days in an incomplete month by 1/30 of the applicable amount.
- 4. It is not possible to increase the rate of the grant in relation to the amount announced by the National Agency.
- 5. Students going for two semesters receive the grant in three instalments; students going for one semester receive the grant in two instalments.
- 6. The mobility participants will be paid 90% of the amount specified in the agreement for a period corresponding to at least one semester. Submission by the participant of an obligatory individual report in the EU survey on-line system and completion of the OLS language test upon return will be treated as the participant's application for payment of the remaining grant amount.
- 7. The University guarantees the grant for a period no longer than originally agreed in the agreement. This means that if the confirmed period of stay in the organisation is longer than that agreed in the agreement or a possible annex to the agreement, the amount of the grant does not change.
- 8. If the confirmed period of stay in the organisation is shorter than that agreed in the agreement or any annex to the agreement, and the difference is greater than 5 days, a proportional part of the grant will have to be returned.
- 9. The mobility participants are subject to a margin of tolerance of 5 days in relation to the period of stay in the organisation originally agreed in the agreement or a possible annex to the agreement. In case of a confirmed period of stay shorter or equal to 5 days in relation to the

- agreed period of stay in the agreement or a possible annex to the agreement, no reimbursement will be required.
- 10. The University does not provide funding to students who, with the consent of the home faculty and acceptance of the host institution, have decided to extend their planned mobility period for another semester. The funding in this situation will be considered as zero. A possible decision to provide an additional grant is only possible if additional funds have been obtained as a result of redistribution by the Erasmus+ National Agency.
